UPON hearing the counsel the Court made the following

ORDER

We have seen the report prepared by learned counsel for the petitioner which is in three volumes.

Learned counsel for the Union of India as well as the States / UTs may respond to the report and give it to learned counsel for the petitioner who may study the responses and file a report. The responses need not be filed in the Court.

It is stated by learned counsel for the petitioner by way of an affidavit that there are some States / UTs that have not created

a link as required and no chart has been filled up.

The defaulting States, with which we are concerned at the present moment, are Jharkhand, Tamil Nadu and Uttrakhand. There is no appearance on behalf of the State of Uttrakhand.

In view of the default of these 3 States, costs of 50,000/-are imposed upon these States. The amount be deposited within four weeks from today with the Supreme Court Legal Services Authority for utilization of juvenile justice issues.

The other defaulting States / UTs are Arunachal Pradesh, Dadar and Nagar Haveli and Puducherry. For the time being, we are not imposing any costs on these States. We expect these States will comply with the directions passed by this Court from time to time.

It has also been pointed out on affidavit that some States have created a link and only one chart has been filled up and in respect of some other States, only the State level chart is filled up and one composite chart as against district / school wise chart.

To comply with the orders of this Court and to ensure that the link contains all the charts duly filled up, list the matter on 20.09.2018.
